# **Continuous Improvement Assessment (CIA)**

Phoenix College made tremendous steps this year in documenting Institutional Learning Outcomes across the college. Kudos to Drs. Marin and Webster for Cochairing assessment and developing a plan that is easy to implement, meaningful, and allows for growth. Also, I want to thank the assessment committee for their participation and engaging dialog throughout the year. Last, but certainly not least,

For Spring 2021, we will continue to schedule classes mostly in the remote learning format due to the pandemic until otherwise directed by the district and/or the local government. Thank you for your continued flexibility and patience during this unique time.

## **Tuition Incentives**

The Maricopa Community Colleges will invest \$13.5M for additional FAFSA-based Student Scholarship Grants for credit and clock hour students, which includes last dollar grants for partial-Pell-eligible students and up to \$400 grants for non-Pell-eligible students.

The Board also approved a 'Flat Rate Full-Time' for students taking more than 12 credit hours. Students registering for more than 12 credits per term will receive the discounted Full-Time Flat-Rate Tuition. Students do not have to preselect this plan but will be automatically enrolled once the 12-credit per term threshold has been reached.

Students who recently moved to Maricopa County with a local permanent address will receive the in-state tuition rate for up to 6 credit hours. For additional hours, these students will then be charged at the current applicable out-of-state rate.

## **Athletics Community Forums**

This week, the District will hold two virtual community forums concerning the recommendation of our System's ten college presidents to temporarily suspend athletic programs during the COVID-19 pandemic. Interim Chancellor, Dr. Steven R. Gonzales, will host the events in collaboration with the Maricopa Center for Learning and Innovation and Deanna Villanueva-Saucedo, District Director of Community Engagement, who will serve as the moderator of the event. The virtual community forums will provide a platform for our students, staff, faculty, and community members to vocalize their concerns and questions about temporarily suspending the Maricopa Community Colleges' athletic programs.

Much like a Citizen's Interim at our Governing Board meetings, participants should limit their opinions and thoughts to three minutes each. You will be required to enter your name and email address prior to joining the event. The password is auto-filled. Please do **NOT** change the password.
